COLAP

Jim Dusza and Chris McCooe attended this year's annual Massachusetts Congress of Lakes and Ponds (COLAP) meeting in Worcester on January 23rd. This year's main message was that funding will be tight. Although Washington has declared an end to the recession, we know better. In fact, this year's Department of Conservation and Recreation budget has been eliminated, from \$500,000 annually down to Zero. There are currently two men staffed to monitor the state's 3000 lakes and ponds. The outlook for 2011 is just as challenging. Some of the COLAP seminars they attended were:

**Lake and Pond Restoration Techniques** – This was an overview of how a healthy lake is defined followed by rudimentary management techniques. The General Environmental Impact Report was introduced as the document which guides the state's position on managing lake and pond resources. The GEIR Report is very comprehensive and requires a companion user guide. The documents are available for your reference and use.

**Using the GEIR and DEP Guidance Documents for Lake and Pond Management Permitting** Using the GEIR and companion documents can facilitate cutting through the red tape when it comes to applying for project permits. By following the guide, virtually all areas of permit questioning can be addressed making the application more comprehensive and direct. This was a valuable workshop for those involved in writing the paperwork to support our activities.

**Community Preservation Act Funds** - CPA funds are collected as part of our tax bills and are available for one-time projects or improvements. Maintenance or recurring actions are not covered by this money. We will be looking into the availability of these funds as they pertain to our projects.

The COLAP workshops are for anyone interested in maintaining our lake's health. Interested in attending future meetings or workshops? Contact one of our officers.

## LOC

The Lake Oversight Commission (LOC) is working with the Highway Department and the Pioneer Valley Planning Commission in finishing the work on the Mashapaug Rd; at Fenton RD., Mashapaug Rd at Stevens Brook and Kimball Hill projects for the current 319 grant. The LOC has started the process of working with the Pioneer Valley Planning Committee for the next 319 grant – the application is due this June.

The LOC continues to work with the Holland Police to make the lake a safe and fun place in the winter as well the summer. Meetings are held the 2<sup>nd</sup> Thursday of each month at 7pm in the Town Hall.

## Fund Raising

As a non profit, The Friends of HRA continues to donate money to projects that help stormwater management around the lake. This year we donated money for materials for a project to stop the stormwater and sediment from Chandler and Chaffee Roads from running into the lake.

And after the water was drawn down in the fall, it was apparent that the sediment at the South Basin Boat Launch was so bad it would have made using the ramp next spring questionable. Friends of HRA donated the money to fund the project to dig out and remove the sediment.

We have also donated flowers and plants to the Holland Senior Center.

**Planting Time is IMPORTANT:** Ideal planting time is when the ground temperature is between 50 and 70 degrees F., usually mid to late April thru first two weeks of May for sunny lawns and until end of May for shady lawns in the North East, then also Month of September to first/second week in October in N.E.. ## BOAT RULES AND WINTER RECREATIONAL VEHICLE RULES

We have had many questions this winter about recreational vehicle rules both on the lake and on the roads around the lake. At this time, the town has no winter rules but, as with the boating rules, the Mass General Law (MGL sections 89 and 90B) rules for motorized winter vehicles apply on Hamilton Reservoir.

Some (not all) of the Mass Gen’l Laws pertaining to snow and recreational vehicles are:

- Snow and recreation vehicles must be registered except when used on land owned by the owner.
- Each snow or recreational vehicle shall be equipped with one or more headlights, a red rear light, a red rear reflector, and an adequate muffler.
- No snow or recreational vehicle shall be operated which makes an unusual or excessive noise or which emits obnoxious fumes.
- Operator and passengers must have protective headgear.
- The operator may not be under the influence of intoxicating liquor, or narcotics, barbiturate or marijuana.
- Age limits.
  - No one under the age of 10 years may operate under any circumstances.
  - 10-12 year olds - only if directly supervised by a person 18 years or older AND on the land on which the operator is domiciled.
  - 12-14 year olds on the lake if directly supervised by someone older than 18.
- No person shall operate within 150 feet of an occupied residence without the permission of the owner or when operating on the property of another for which permission was granted.
- Can’t drive on private property.
- When approaching a skier, snowshoer, hiker or other foot traveler shall immediately slow the vehicle and shall not accelerate until there is a reasonable distance of no less than 50 feet.
- Can’t drink in front of anyone
- After coming to a complete stop a snow or recreational vehicle may cross directly as possible a public way, except a controlled access highway providing that such a crossing can be made in a safe manner and it does not interfere with the free movement of vehicular traffic. No snow vehicle or recreational vehicle shall be operated on the main traveled portion of a way, or on that portion of a way that has been plowed or on a snow bank immediately adjacent to the plowed portion of the way.
